Wedgeport Boats Limited Warranty

Wedgeport Boats Limited supplies a general one-year warranty which applies only to the vessel and those components manufactured exclusively by Wedgeport Boats Limited or installed by Wedgeport Boats Limited and not covered by a specific manufacturer's or supplier's warranty.

Limited One Year Vessel Warranty

Wedgeport Boats Limited warrants each vessel to be free of defects caused by faulty workmanship or defects in materials under normal use and service for a period of one year from date of manufacture. During this period warranty repairs will be made without charge, either by Wedgeport Boats Limited or, at Wedgeport Boats Limited's option, by an authorized repair centre. It is the responsibility of the owner of the vessel to notify Wedgeport Boats Limited in writing of any defects, which may need to be rectified under this warranty. All warranty repairs must have the prior approval of Wedgeport Boats Limited before repairs are commenced. Wedgeport Boats Limited will not be responsible for the cost of repairs carried out without their prior written authorization.

Technicians Transportation Expenses/Time

Wedgeport Boats will pay reasonable ground transportation fare and normal business labor rate for up to two (2) hours for the repairing technicians travel to and from the repair / replacement site. The owner is responsible for any airfare, meals and lodging and time in excess of two hours at the same labor rate. If requested by, owner will be responsible to pay additional labor rates (over time rates) after normal business hours.

Exclusion From Warranty

Warranty does not apply to:

Engine, outdrives, controls, propellers, batteries or any accessories carrying their own individual warranties.

Installation of engines or any accessories installed by anyone other than Wedgeport Boats Limited.

Windshield breakage.

Paint/gelcoat finishes including hull, cabin or bottom paints. Corrosions including galvanic corrosion.

Canvas, vinyl, upholstery, plastic, fabric or trim.

Any Wedgeport Boats Limited vessel, which has been altered from its original configuration, subject to misuse, negligence or accident or used for racing purposes.

Damage caused by accident or through trailer damage.

Improper Service, Maintenance:

Wedgeport Boats is not responsible for repair (or replacement) or any defect caused by any failure to perform proper service and maintenance or by any failure to use proper fuel, oil, lubricants, coolants and etc, as required or recommended.

The obligation of Wedgeport Boats Limited shall be limited to the repair or replacement of any parts, which are judged to be defective by Wedgeport Boats Limited. Wedgeport Boats Limited will not be liable for costs or charges derived from inconveniences, loss of use, financial or commercial losses howsoever caused. Neither shall Wedgeport Boats Limited be liable for haul out, launching, towing or storage charges, inconveniences or loss of time or income, or any other consequential damages of any kind or nature.
